Subject:- Free/Concessional Travel Facility to the male students of Haryana extending the facility from 60 kms to 150 kms.

Reference your Single file TRA No. 1667 dated 12.02.2024 on the subject noted above.

2. Government agrees with the proposal of Department to extend the Free/Concessional Travel Facility to the male students of Haryana from 60 kms to 150 kms alongwith the following conditions:-

- I. The free passes will be issued to all boy students of the state studying in school/colleges/institutes situated in the state which are recognized by the state Government/affiliated with any university or board in the state. The educational centers, coaching centers, study centers, distance learning centers and franchisees centers of Hartron and other centers, which are affiliated with the universities of other State(s) and are not recognized by the Haryana Government will not be covered under this policy.
- II. The passes will be issued upto maximum limit of 150 Kms.
- III. The passes will be issued on the half yearly basis on the recommendations of the school/college/institution authorities.
- IV. The concerned school/college/institution will supply to the concerned depot Haryana Roadways a list of boy student's alongwith an atteste copy of the recognitions/affiliation certificate issued by the competent authority.
- V. The passes will be issued by the respective General Manager or and officer designed by him as per the list supplied by the school/college/institution.
- VI. The design/format for the pass will remain the same. However, the colour of the pass may be changed for easy recognition for which DST/DGST will issue necessary instruction to all the field offices separately.
- VII. ~~The~~ The respective GMs will keep/maintain proper record of the passes issued to the boy students so as to get the financial

implications reimbursed from the concerned beneficiary department.

VIII. Free travelling pass will be issued once in case the bus pass is lost, duplicate pass will not be issued.

IX. Student will be able to only single journey in a day and journey record will be attached with bus pass on which conductor will signature when student travel in the bus.
